The Temecula Valley Symphony is holding a Young Artist Competition on March 11, 2018 (Sun.) and will select three winners who will each receive cash prizes: 1st place \$400, 2nd place \$300 and 3rd place \$200. The audition committee will select one or two winners to perform one movement of their concerto with the Symphony, live in concert, on Saturday, April 14, 2018 at 2:00 pm in Murrieta, CA.

ELIGIBILITY REQUIREMENTS

- ◆ Applicant must reside in one of these counties: Riverside, San Bernardino, San Diego, or Orange.
- ◆ Auditions are open to any instrumental student through age 25. We are allowing college students to enter the 2018 competition.
- ◆ Previous 1st place winners are not eligible to audition on the same instrument. Previous 2nd or 3rd place winners may participate.

REPERTOIRE REQUIREMENTS

- ◆ Instrumental contestants should prepare one movement of a concerto taken from Standard Orchestral Repertoire. Concerto selections are subject to approval by the Audition Committee prior to acceptance into the competition.
- ◆ **The concerto must require orchestral accompaniment, preferably composed before 1900. Pieces composed after 1900 are subject to approval due to the cost of rental or purchase of the music.**
- ◆ Memorization is not required but encouraged.
- ◆ Soloists must provide their own accompanist.
- ◆ 10 minutes will be allowed for each contestant with an allotted playing time of approximately 7 minutes.
- ◆ Two pianos are available at the audition venue.

ADJUDICATION

- ◆ Contestants must provide TWO COPIES of their music to be performed, for the judges.
- ◆ The adjudication panel will consist of professional musicians and teachers.
- ◆ No adjudicator will be allowed on the judges panel who has a student enrolled in the competition.

AUDITION TIME & LOCATON

- ◆ The competition will be held at Miyamoto Music Studio in Temecula located at 28780 Old Town Front St., Suite C1, Temecula, CA 92592
- ◆ Contestants will be notified as to their audition time slot.
